JUDGMENT

This matter came on for trial on November 13, 2008 with respect to Plaintiffs' claims in the Complaint against Clayton Kimbrell and Trevor Reed. For the reasons stated on the record by the Court at the conclusion of the trial, it is hereby

ORDERED, ADJUDGED AND DECREED, as follows:

(a) that Plaintiffs are entitled to a judgment against Clayton Kimbrell and Trevor Reed, jointly and severally, in the amount of \$1,453,665.08, pursuant to Counts XXVIII (Breach of Fiduciary Duty) and XXIX (Fraud) of the Complaint, plus pre-judgment interest at the legal rate provided for in 28 USC Section 1961 of 4.83% per annum in the amount of \$90,217.64 since the date of service of the Complaint (August 5, 2007, which date includes three days for service by mail) through the date of judgment, plus \$150.00 for court costs, for a total judgment in the amount of \$1,544,032.72, plus post-judgment interest at the legal rate provided for in 28 USC Section 1961 of 1.24%; and

(b) nothing herein shall prejudice the Plaintiffs' claims against any other Defendants in this Adversary Proceeding or any defenses the other Defendants may have to Plaintiffs' claims that were not previously adjudicated by the Court's May 22, 2008 Order.
