**RESOLUTION
OF COLON END PARENTHESIS TRUST, LLC**

The undersigned, acting pursuant to authority granted to him by Order of the United States District Court for the Eastern District of North Carolina (the "District Court Order"), does hereby expressly waive notice of the date, time, place and purpose of, and rights to receive any material otherwise required to be furnished in a notice of a meeting at which the actions herein taken would have been submitted to Colon End Parenthesis Trust, LLC (the "Company") managers or members, and does hereby consent to the taking of, and does hereby take, the following actions:

WHEREAS, on July 10, 2007, the United States District Court for the Eastern District of North Carolina entered an Order Granting Preliminary Injunction, Freezing Assets, Appointing A Receiver and Ordering Other Ancillary Relief. See SEC v. CEP Holdings, Inc., et al, Civil Action No. 5:07-cv-00256-BO, which, among other things, appointed William F. Perkins as receiver of the Company;

WHEREAS, the District Court Order grants to William F. Perkins the exclusive authority to take any action which could be taken by the directors of the Company, including the filing of a voluntary petition under Title 11 of the United States Code in which case Mr. Perkins shall be empowered to operate the Company as debtor in possession, with all of the powers and duties of a debtor in possession;

WHEREAS, William F. Perkins, acting pursuant to the authority granted to him by the District Court Order, after due and careful consideration of the financial situation of the Company and the Company's available alternatives, has determined that it is in the best interests of the Company and other parties in interest to commence voluntary proceedings under Chapter 11 of Title 11 of the United States Code (the "Bankruptcy Code");

NOW, THEREFORE, BE IT RESOLVED, that it is in the best interests of the Company and other interested parties, that a petition under Chapter 11 of the Bankruptcy Code (the "Petition") be filed by the Company;

RESOLVED FURTHER, that William F. Perkins is hereby authorized and empowered on behalf of, and in the name of, the Company to execute and verify or certify a Petition under Chapter 11 of the Bankruptcy Code and to cause the same to be filed in the appropriate district court of the United States as he may determine (the "Bankruptcy Court"), at such time as Mr. Perkins shall determine and in such form as he may approve;

RESOLVED FURTHER, that, upon William F. Perkins' determination that a Petition shall be filed, any of the agents of the Company be and are hereby authorized and directed to implement the filing of the Petition and the prosecution of the case initiated thereby, including the execution and filing of the Petition and any and all necessary pleadings, motions and applications incident thereto, and to execute and supply any and all schedules, statements of affairs, lists, and all other information and reports required by the Bankruptcy Code, the Federal Rules of Bankruptcy Procedure, the Local Rules of the Bankruptcy Court, the United States Trustee or Bankruptcy Administrator Guidelines, and any other appropriate rules or regulations;

RESOLVED FURTHER, that, upon William F. Perkins' determination that a Petition shall be filed, William F. Perkins is authorized to apply to the Bankruptcy Court for authority to retain the services of professionals to represent and assist the Company in carrying out the duties in its Chapter 11 case, and that William F. Perkins be and is hereby authorized to retain Greenberg Traurig LLP to serve as general bankruptcy counsel, and, in connection therewith, Greenberg Traurig LLP shall be compensated for its services and expenses on the basis of its usual and customary fees and expenses or when applicable, pursuant to agreement reached with Greenberg Traurig LLP, subject to the approval of the Bankruptcy Court;

RESOLVED FURTHER, that, upon William F. Perkins' determination that a Petition shall be filed, William F. Perkins is authorized to apply to the Bankruptcy Court for authority to retain the services of professionals to represent and assist the Company in carrying out the duties in its Chapter 11 case, and that William F. Perkins be and is hereby authorized to retain W.G. Hays & Associates, LLC to serve as financial advisors and accountants, and, in connection therewith, W.G. Hays & Associates, LLC shall be compensated for its services and expenses on the basis of its usual and customary fees and expenses or when applicable, pursuant to agreement reached with W.G. Hays & Associates, LLC, subject to the approval of the Bankruptcy Court; and

RESOLVED FURTHER, that, upon William F. Perkins' determination that a Petition shall be filed, William F.
